The Georgia Rotary Clubs' Laws of Life Essay Contest challenges high school students to write about the core character values that matter most in their lives - values such as honesty, perseverance, generosity and compassion. By encouraging students to reflect deeply on key life principles, the Laws of Life contest promotes and rewards the development of good character and changes lives for the better.

The contest also promotes advanced literacy by encouraging high school students to develop essential writing and analytical skills, and by assisting teens in making articulate arguments for their ethical beliefs.

A Signature Georgia Rotary Outreach Program

The Georgia Laws of Life Essay Contest reaches more students than any other Rotary program in our state. For the 2013-2014 contest, 41,809 Georgia students wrote a Laws of Life essay, and the contest presented more than \$19,000 in student and teacher prize money.

The Georgia Laws of Life contest is operated by the non-profit Georgia Rotary Districts Character Education Program (GRDCEP), which is wholly operated by Rotarians and approved by Rotary International. The contest is sponsored by Rotary clubs, by corporate and family foundations, and by individual donors.

By sponsoring the Georgia Rotary Clubs' Laws of Life contest, your club can:

- Introduce an effective character education and literacy program in local high schools;
- **Encourage** teenagers to reflect on values such as those in the 4-Way Test:
- Connect with local educators, students and parents in a positive, values-affirming
- Have a memorable program each spring as winning students read their essays and receive recognition at a club meeting or special event;
- Promote Rotary in your community.

2014-2015 Georgia *Laws of Life* Essay Contest Rotary Club Sponsorship Information

GENERAL RESPONSIBILITES:

- 1) Sponsor a local high school **or serve as a general contest sponsor**. (General sponsorships allow schools without a local Rotary club to participate in the program.)
- 2) Provide financial support as a Bronze (\$500), Emerald (\$750) Silver (\$1,000), Gold (\$1,500), Platinum (\$2,000), Diamond (\$2,500) or Presenting (\$5,000) Sponsor.
- 3) Recognize the club's school winners at a club meeting or similar in the spring. (Not required if serving as a general sponsor.)
- 4) Optional: Assist in essay judging.

TIMELINE:

Spring / Summer, 2014:

- If you wish to be sponsor a specific school, contact the principal or English Department Chair, after coordinating with the Georgia Laws of Life Essay Contest, and present him/her with a Laws of Life School Information Package. The package is available by request from georgialawsoflife@gmail.com or 404.590.8039.
- Complete the Rotary club registration form and return to the Laws of Life contest.

For clubs sponsoring a particular school, the following deadlines apply:

Summer / Fall 2014:

- Let the School Contest Chair know you are available to help and answer questions. Continue to stay in contact with the teacher every few months, to make sure that the school is on-track with the contest.
- Set aside a meeting in late April or May to recognize the school's essay winner(s), or otherwise plan for a student recognition event.

February – mid-April, 2015:

- In February, your club will be contacted about opportunities for club members to serve as essay judges. (Participation in judging is optional.)
- In late March or early April, the Georgia Laws of Life Essay Contest announces the student winners and issues the student award and teacher honoraria checks.

Mid-April – mid-May 2015:

Clubs host a student recognition event and invite student winners to read their essays aloud.
